- 4. The school shall admit in pre-school / class I to the extent of 25(%age) of the strength in each class, children belonging to Weaker Section and Disadvantaged Group in the neighborhood and provide free and compulsory elementary education till its completion.
- 5. The school shall maintain a separate bank account for the purpose of reimbursement.
- 6. The school shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
- 7. The school shall not deny admission to any child, -
  - For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
  - b. On the ground of religion, caste or race, place of birth or any of them.
- 8. The school shall ensure that,
  - a. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
  - b. No child shall be subjected to physical punishment or mental harassment.
  - c. No child is required to pass any board examination till the completion of elementary education.
  - d. Inclusion of students with disabilities/ special need as per provision of the RTE 12(I)(C)(rule/clause of State Act).
  - e. The teachers are recruited with minimum qualifications as laid under RTE 12(I)(C)(rule/clause of the state Act).
  - f. The teachers perform his duties specified under RTE 12(I)(C) (rule/clause of the state, Chiefrein Act).

- The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
- 10. The school shall maintain the standards and norms as specified in RTE Act 2009 (rule/ clause of
- 11. No unrecognized classes shall run within the premises of the school or outside in the name of
